

**Pizza Hut® Golden Garlic Knots Pizza Giveaway**  
OFFICIAL RULES

NO PURCHASE NECESSARY TO PARTICIPATE, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT  
WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

**Who May Participate:** The Pizza Hut® Golden Garlic Knots Pizza Giveaway ("Promotion") is sponsored by Pizza Hut, Inc., 7100 Corporate Drive, Plano, Texas 75024 ("Sponsor") and is open to legal residents of Texas, Ohio, Rhode Island, Mississippi, Georgia, Louisiana and West Virginia who are 18 years of age or older (or at least the age of majority in their jurisdiction of residence, whichever is older). Employees, officers, directors and assigns of Sponsor, its affiliated companies, subsidiaries, distributors, dealers, retailers, printers, advertising, and sweepstakes agencies, and any and all other companies associated with the design or execution of this Promotion (collectively, "Released Parties"), and the members of the immediate families (spouse, parent, sibling and child and their respective spouses, regardless of where they reside) or households of any of the above, whether or not related, are not eligible to participate or win. Void outside of Texas, Ohio, Rhode Island, Mississippi, Georgia, Louisiana and West Virginia and where prohibited. Promotion is subject to all applicable federal, state and local laws.

**Promotion Period:** Promotion will take place during standard business operating hours at participating Pizza Hut store locations in Texas, Ohio, Rhode Island, Mississippi, Georgia, Louisiana and West Virginia beginning at 1:00 p.m. Eastern Time ("ET") and ending at 5:00 p.m. ET on February 7, 2016 ("Promotion Period").

**How to Participate:** During the Promotion Period, there are two (2) ways to participate;

**1. Stuffed Garlic Knots Pizza Order:** Visit a participating Pizza Hut store location or make a delivery order from a participating Pizza Hut store location that includes a Pizza Hut Stuffed Garlic Knots Pizza in your order to automatically receive one (1) game play (each, a "Game Play"). Each order will immediately trigger a winning or losing result. If a winning result is triggered, you are the potential winner of the specified prize and will immediately receive your prize from a Pizza Hut Representative with your in-store or delivery order. If a losing result is triggered, you are not a prize winner and will not receive a prize or any notification from Sponsor or a Pizza Hut representative. Orders must be received by Sponsor no later than 5:00 p.m. ET on February 7, 2016 to be eligible.

**2. Email:** To receive one (1) Game Play without ordering a Pizza Hut Stuffed Garlic Knots Pizza, send an email with the subject line "Golden Garlic Knots Pizza Giveaway" to PR@PizzaHut.com with your complete name, mailing address, date of birth, and phone number (including area code). Each email will immediately trigger a winning or losing result. If a winning result is triggered, you are the potential winner of the specified prize and will immediately receive an email notification from Sponsor within one (1) hour from time of email receipt. If a losing result is triggered, you are not a prize winner and will not receive a prize or any notification from Sponsor or a Pizza Hut representative. Emails must be received no later than 5:00 p.m. ET on February 7, 2016 to be eligible.

Limit one (1) Game Play per person throughout the entire Promotion, regardless of location visited or method of participation. You may only use one (1) email address to participate in the Promotion.

**Prize Allocation & Odds of Winning:** Each Promotion prize will be randomly assigned to a specific time throughout the Promotion Period. The odds of winning a prize depend on the date and time of participation. The participant who, as determined by Sponsor in its sole discretion, first submits a valid Game Play on (or the first person who submits a Game Play after that time if no one submits it at that time) the randomly pre-assigned specific time will be eligible to win the prize assigned to that time and immediately receive his/her prize with their order (or if participating via email the winner will be sent an email to the email address provided with prize claim instructions).

**How to Claim Prize:** Prior to receiving their prize with their in-store or delivery order, potential winners that participated by purchasing a Stuffed Garlic Knots Pizza will be required to execute and return a liability and publicity release provided by Sponsor.
