

# **PIZZA HUT® #PIZZAHUTHUT FLICK FOOTBALL SWEEPSTAKES**

## **OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE.  
A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

**OPEN ONLY TO ELIGIBLE LEGAL RESIDENTS OF THE 48 CONTIGUOUS UNITED STATES AND THE DISTRICT OF COLUMBIA WHO ARE 18 YEARS OR OLDER AS OF DATE OF ENTRY.  
VOID IN ALASKA, HAWAII, PUERTO RICO AND WHERE PROHIBITED.**

The Pizza Hut #PIZZAHUTHUT Flick Football Sweepstakes ("Sweepstakes") is sponsored and administered by Pizza Hut, LLC ("Sponsor"), 7100 Corporate Drive, Plano, TX 75024. Twitter® is not an official sponsor of this Sweepstakes.

**SWEEPSTAKES TIMING:** The Sweepstakes begins at 9:00:00 AM Central Time ("CT") on Monday, August 29, 2016 and ends at 11:59:00 PM CT on October 14, 2016 ("Sweepstakes Period"). There will be a random drawing on each Sunday of the sweepstakes to determine a weekly winner. Sponsor's computer is the official clock of the Sweepstakes.

**1. ELIGIBILITY:** The Sweepstakes is offered only to legal residents of the 48 contiguous United States and the District of Columbia who are at least 18 years of age at the time of entry. Employees, officers and directors of Sponsor and its parent company, subsidiaries, affiliates, franchisees, and advertising agencies, Sweepstakes and web design agencies, and other individuals/entities associated with this Sweepstakes (the "Sweepstakes Entities") are not eligible to enter or win. Void in Alaska, Hawaii, Puerto Rico, and where prohibited or restricted by law. All federal, state and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. **2. HOW TO PARTICIPATE:** During the Sweepstakes Period, visit [www.twitter.com](http://www.twitter.com), log-in or create a Twitter account and follow @pizzahut. Creating a Twitter Account is free but is subject to Twitter's Terms of Service (<http://twitter.com/tos>). Your account settings must allow for all of your posts to be public and thus viewable by Sponsor and its agents. During the Sweepstakes Period, Pizza Hut will ask fans to tweet @PizzaHut using #PIZZAHUTHUT and post a video playing with the Pizza Hut flick football box. Tweet an entry including #PIZZAHUTHUT and THE VIDEO and include @pizzahut handle in your Tweet. You will be automatically entered into the random drawing each week of the sweepstakes period. Eligible entrants can enter as many times as they choose during the Sweepstakes Period. Limit one (1) Prize per winner. Winners will be selected by random drawing and notified via Twitter Direct Message from @pizzahut. Tweets may not be indecent, obscene, hateful, tortious, defamatory, or libelous or contain material that violates or infringes another's rights, or disparage Sponsor or any other person or party affiliated with the Sweepstakes, or contain material that is unlawful in any way. Sponsor reserves the right to disqualify any entrant where it finds the content of the Tweet to be unlawful, or in violation of these Official Rules, all in its sole discretion. Multiple entrants are not permitted to share the same Twitter handle. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different Twitter handles, identities, registrations and logins, or any other methods will void that entrant's entries and that entrant may be disqualified. Use of any automated system to participate is prohibited and will result in disqualification. In the event of a dispute as to any registration, the authorized account holder of the Twitter handle used to register will be deemed to be the entrant. Each potential winner may be required to show proof of being an authorized account holder.

**3. RANDOM DRAWINGS:** Sponsor's decisions as to the administration and operation of the Sweepstakes and the selection of the potential winners are final and binding in all matters related to the Sweepstakes. During the Random Drawing, Sponsor will randomly select five (5) potential Sweepstakes winners from all eligible entries each week with a total of thirty-five (35) winners throughout the sweepstakes period. Sponsor will contact and send each potential winner his/her Prize through a Direct Message on Twitter on or about one (1) business day after the random drawing. In order to receive the Message, the potential winner's "Tweet Privacy" Account setting must be "unchecked." If a potential winner of

**A. Prizes:** Sponsor will direct message the Winners on Twitter and send the Prize.
