## Official Rules

## PIZZA HUT PIE TOPS @PHALLAMERICAN SWEEPSTAKES SPONSORED BY PIZZA HUT, LLC

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID OUTSIDE OF THE FIFTY UNITED STATES AND THE DISTRICT OF COLUMBIA AND WHERE PROHIBITED OR RESTRICTED BY LAW.

- 1. Sweepstakes Period: The "Pizza Hut Pie Tops @PHAllAmerican Sweepstakes" ("Sweepstakes") takes place on Thursday, March 30, 2017 from 8:00 a.m. PT to 11:59 p.m. PT ("Sweepstakes Period"). The Sponsor's time clock will be the official time keeping device for this Sweepstakes. All interpretations of these Official Rules and decisions made by Sponsor relating to the Sweepstakes are final.
- 2. Eligibility: The Sweepstakes is open to persons legally and physically residing in one of the 50 United States or the District of Columbia who are at least the age of majority in their state of residence at time of entry: 18 years of age in most states, 19 in Alabama and Nebraska, 21 in Mississippi. Employees, agents, directors of Pizza Hut, LLC ("Sponsor"), The National Collegiate Athletic Association ("NCAA®"), its affiliated companies, subsidiaries, partners, dealers, manufacturers, distributors, sponsors, advertising agencies, Sweepstakes and administration agencies and any entity which is involved in any aspect of the creation, production, operation, execution or fulfillment of the Sweepstakes ("Sweepstakes Entities"), and their immediate families (i.e., parents, spouse, siblings, children, grandparents, step parents, step children and step siblings, and their respective spouses, and those living in the same household, whether or not related) are not eligible to enter Sweepstakes.

The content of your comment will not be judged and will therefore not increase or decrease your chances of winning a prize. Limit one (1) entry per person using only one (1) Instagram or Twitter account throughout the Sweepstakes Period. In order for entrant to submit an eligible entry via Instagram or Twitter, entrant must have a valid Instagram or Twitter account set as non-private. By participating in Sweepstakes, entrants hereby agree that Sponsor may collect and use their personal information in compliance with its Privacy Policy and acknowledge that they have read and accepted the Sponsor Privacy Policy.

There is a limit of one (1) entry per person per Sweepstakes Period, regardless of the Instagram or Twitter account or photo selected to enter. In the event of a dispute over who submitted a winning entry, the "authorized account subscriber" of the Instagram or Twitter account used to participate in Sweepstakes at the actual time of entry, will be deemed to be the entrant. It is the sole responsibility of the entrant to notify the Administrator in writing if the entrant changes his or her email account during the Sweepstakes Period. Proof to Sponsor's satisfaction of being the authorized account subscriber may be required by Sponsor.

Further, entries must not contain any claim that is not, and cannot be, substantiated or that would be false or misleading to a reasonable consumer. Any content, text or otherwise, included as part of the entry must be in the English language.

Sponsor reserves the right to disqualify any entry that it deems, in its sole discretion, to be a violation of the Official Rules or that is not in keeping with the Entry Guidelines specified herein or which communicate messages or images inconsistent with the positive images and/or good will to which Sponsor wishes to associate.

Each winner will receive a pair of Pizza Hut Pie Tops, with an approximate retail value ("ARV") of \$500 and a \$50 credit card gift card, the ("Prize" and collectively "Prizes"). The total ARV of all of the Prizes is \$1,100. Prizes will be sent to each Winner within approximately seven (7) days from the end of the Sweepstakes Period.
- 7. **Publicity Release:** Each Winner grants to Sponsor, and its representatives, affiliates, licensees and assigns, the right and permission to record, film, videotape and photograph the Winner ("Images"). These Images will be owned by Sponsor.
