### **Official Rules**

# The Literacy Project Giveaway SPONSORED BY PIZZA HUT, LLC

NO PURCHASE NECESSARY TO ENTER OR WIN A PRIZE. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF RECEIVING A PRIZE. VOID OUTSIDE OF THE FIFTY UNITED STATES AND THE DISTRICT OF COLUMBIA AND WHERE PROHIBITED OR RESTRICTED BY LAW.

- **1. Promotion Period:** The Literacy Project Giveaway ("<u>Promotion</u>") begins at 12:00 a.m. Central Time ("<u>CT</u>") on February 26, 2018 and ends at 11:59 p.m. CT on April 15, 2018 ("<u>Promotion Period</u>"). The Sponsor's time clock will be the official time keeping device for this Promotion. All interpretations of these Official Rules and decisions made by Sponsor relating to the Promotion are final.
- **2. Eligibility:** The Promotion is open to persons legally and physically residing in one of the 50 United States or the District of Columbia who are at least the age of majority in their state of residence at time of entry: 18 years of age in most states, 19 in Alabama and Nebraska, 21 in Mississippi. Employees, agents, directors of Pizza Hut, LLC ("Sponsor"), PrizeLogic, LLC, their affiliated companies, subsidiaries, partners, dealers, manufacturers, distributors, sponsors, advertising agencies, promotion and administration agencies and any entity which is involved in any aspect of the creation, production, operation, execution or fulfillment of the Promotion ("Promotion Entities"), and their immediate families (*i.e.*, parents, spouse, siblings, children, grandparents, step parents, step children and step siblings, and their respective spouses, and those living in the same household, whether or not related) are not eligible to participate in the Promotion.

Instagram:** Entrants must (i) log onto their Instagram account; and (ii) post a photo with a caption that describes their favorite book and also include the hashtags #HelpStartANewChapter and #sweepstakes in your post to receive one (1) entry. **The content of your post will not be judged and will therefore not increase or decrease your chances of winning a prize.** 

Limit one (1) entry per person per social media channel throughout the Sweepstakes Period (for a maximum of two (2) entries per person/email address throughout the Sweepstakes Period). Entries received from any social media account/email address in excess of the above stated limitation will be void. In order for entrant to submit an eligible entry via Twitter or Instagram, entrant must have a valid Twitter or Instagram account set as **non-private**. Entrant must not use more than one (1) social media/email account to participate in Sweepstakes. Message and data rates may apply if entrant participates in Sweepstakes via mobile device.

All information submitted to Sponsor by entrants is subject to and will be treated in a manner consistent with Sponsor's Privacy Policy accessible at **www.pizzahut.com**. By participating in Promotion, entrants hereby agree that Sponsor may collect and use their personal information in compliance with its Privacy Policy and acknowledge that they have read and accepted the Sponsor Privacy Policy.

In the event of a dispute over who submitted a winning entry, the "authorized account subscriber" of the Twitter/Instagram/email account used to participate in Promotion at the actual time of entry, will be deemed to be the entrant. Proof to Sponsor's satisfaction of being the authorized account subscriber may be required by Sponsor.

**4. Prize (1):** Winner will receive a trip for winner and up to three (3) guests to a location similar to the setting of their favorite book mentioned in their winning entry. Exact travel destination will be determined by Sponsor, in its sole discretion. Trip consists of roundtrip, coach class air transportation from a major U.S. gateway airport near winner's

residence to designated location, four (4) days and three (3) nights standard hotel accommodations (one room, double occupancy), and ground transportation to/from airport and hotel, and \$500 per diem which can be used towards meals and activities while on trip. If winner resides within a 100-mile radius of destination, ground transportation will be provided in lieu of air transportation and no compensation or substitution will be provided in lieu thereof. Sponsor reserves right to change dates. Winner and guest must travel together on the same itinerary. Guest must be of legal age of majority in his/her jurisdiction of residence (and at least 18), unless the child or legal ward of winner and must sign a liability/publicity release prior to issuance of travel documents. If guest is child or legal ward of winner, winner must sign and return release on behalf of such child or legal ward. Travel must be made through Sponsor's agent, on a carrier of Sponsor's choice. Travel is subject to availability. Certain blackout dates and travel restrictions may apply.

Winner Verification:** Sponsor will attempt to contact the potential winner via social media direct message, comment or email on or about April 20, 2018 and potential winner must respond to Sponsor within three (3) days with the information requested to be eligible for prize receipt. If potential winner does not respond within the allowed period of time, or does not meet the eligibility requirements of these Official Rules, an alternate potential winner may be selected and notified. The potential winner will be required to execute an Affidavit of Eligibility and Liability Release and may be also required to provide a copy of a driver's license, passport or similar government issued identification when notified of being the potential winner. Providing potential winner is in compliance with the Official Rules and has successfully completed the required documents and eligibility requirements, the potential winner will be confirmed and verified as the winner. In the event of non-compliance by the potential winner such potential winner shall be disqualified and all privileges otherwise due as an winner shall be terminated and an alternative potential winner may be notified. Sponsor expressly reserves the right to delay the announcement of the winner for any reason Sponsor deems necessary. In addition, Sponsor reserves the right to select an alternate winner in event that a potential winner fails to comply with these Official Rules.

By participating in Promotion, winner acknowledges that Promotion Entities have not and will not obtain or provide insurance of any kind relating to the prizes and that an winner will be responsible for obtaining and paying for any form of insurance relating to the prize that winner deems appropriate.

Prize Terms: If for any reason prize is unavailable or any prize or related event is delayed, cancelled or postponed, or for any other reason, Sponsor reserves the right to modify the Promotion in its sole discretion and award a substitute prize, of comparable or greater value as set forth in these Official Rules. No substitution, transfer, assignment or cash equivalent of the Prize, or any portion thereof, is permitted by the Winner. Promotion Entities shall have no responsibility or obligation to the Winner who is unable or unavailable to, or who does not for any reason, accept or utilize the Prize. All costs and expenses not specifically listed above as part of the prize are solely Winner's responsibility. PRIZE IS PROVIDED "AS IS". If, for any reason Promotion is not capable of running as planned, including, without limitation, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the reasonable control of Promotion Entities, which, in Sponsor's sole determination, corrupts or affects the administration, security, fairness, integrity or proper conduct of this Promotion, Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend Promotion, or any part of the Promotion. If Promotion or any part of the Promotion is terminated or modified prior to the closing date of the Promotion, notice will be posted on Pizza Hut social channels if time permits and Sponsor reserves the right to conduct a random drawing from among all eligible entries received prior to such action taken to award the prize. Sponsor reserves the right to modify and amend these Official Rules from time to time during Promotion for clarification purposes.
